1. Upon receipt by the Country Club of (a) this completed Contract, (b) the completed Inner Club Membership Contract, (c) the completed applicant's information form and (d) the annual fee for the amount of the package being chosen:
  - a. \$1000 per individual
  - b. \$1750 couple (includes spouse or domestic partner)
2. Upon execution by the Country Club's Head Golf Professional, General Manager or Corporate Officer of this Agreement, the applicant shall be admitted to and become a Participant ("Participant") of the Golf Cart Package.

Upon being accepted for participation in the Golf Cart Package, participants shall be entitled during the current year to unlimited golf cart fees on both the 18 Hole Par 72 course and 9 Hole Par 3 course.

By applying for participation in Golf Cart Package, participant acknowledges, accepts and agrees to the following terms and conditions of the Golf Cart Rental Agreement.

- A. The Golf Cart shall be returned to the cart barn immediately, following the completion of (1) round of golf.
- B. The Golf Cart membership applies to only the cart member themselves. Any guest riding in the cart with the member must pay the prevailing daily rate.
- C. The Golf Cart shall be returned in good condition. You are responsible for any damage to the cart while it is in your possession.
- D. All persons using the Golf Cart shall drive only on cart paths and other areas marked for travel, and shall comply with all posted driving instructions. Please see stated 18 Hole Par 72 and 9 Hole Par 3 course policies.
- E. The Renter represents that he/she is at least 16 years of age, holds a valid drivers license, and is familiar with the operation of the golf cart.
- F. The Renter shall indemnify and hold the Country Club, its employees and agents, harmless from and against any claims arising out of the use of the said golf cart. The Renter agrees to be responsible for all users of the Golf Cart until it is returned to the cart barn.
