2017 PAR 3 SEASON INNER CLUB PACKAGE CONTRACT

The Atkinson Resort & Country Club, 85 Country Club Drive, Atkinson, NH, 03811 ("Country Club"), 2017 Par 3 Season Inner Club package is referred to below as "Par 3 Season Package".

The Applicant hereby applies to become a participant of "Par 3 Season Package" beginning _____ and ending December 31, 2017.

1. Upon receipt by the Country Club of (a) the completed Contract, (b) the completed applicant's information form and (c) the annual fee for the amount of the package being chosen:
 - a. \$695 per individual
 - b. \$1095 per couple (includes spouse or domestic partner)
 - c. \$400 each additional immediate family member age 17 and under
2. Upon execution by the Country Club's Head Golf Professional, General Manager, or Corporate Officer of this agreement, the applicant shall be admitted to and become a Participant ("Participant") of Par 3 Season Package.

Upon being accepted for participation in the Par 3 Season Package, Participants shall be entitled during the current year to the following privileges:

1. Unlimited greens fees on the 9 Hole Par 3 course
2. Priority in reserving a tee time for up to **seven (7) days** in advance
 - Two (2) day advantage over non-participants
3. Priority in reserving a tee time for the 18 Hole Par 72 course up to **seven (7) days** in advance
4. Unlimited Practice Facility privileges
 - During hours of operation
 - First come, first serve basis
 - From April 1 - November 1
 - Excludes use of Willowcreek Golf Academy
5. Discount on select merchandise
6. Complimentary Atkinson Resort & Country Club gift
7. 2017 USGA handicap service
8. Discounted Virtual Golf rates in Merrill's Tavern Game Room
9. Men's and Women's locker room amenities
 - During posted hours
 - Locker use on first come first serve basis
 - Showers and towel service
 - Fitness equipment on first come first serve basis
10. Fieldstone Suites room rate of \$99 per night (based on availability)

By applying for participation in Par 3 Season Package, Participant acknowledges, accepts and agrees to the following terms and conditions of his/her/their continued participation in Par 3 Season Package.

- A. This participation is not transferable to or useable by any other person or persons other than the Participant themselves.
- B. Each Participant and their guests accept responsibility for compliance with the stated rules and policies of the Country Club.
- C. The Participant must notify the Country Club by telephone prior to the start of any tee time that the number in such Participant's party is not the number reserved for; failing which, the Country Club reserves the right to add waiting singles to the Participant's group. If a Participant shows up more than twice with fewer players in his/hers/their group than was previously booked and without such prior notice to the Country Club, the tee time booking privileges under the Par 3 Season Package may be suspended or revoked.
- D. In the event Participant or any of his/her/their guests that form the group for which a reservation has been made is not checked in with the Willowcreek Pro Shop at least fifteen (15) minutes prior to the scheduled tee time the Country Club reserves the right to allow waiting groups to precede the Participant and cause the Participant and his/her/their group to forfeit their tee time.
- E. The Country Club reserves the right to terminate a Participants participation in Par 3 Season Package for breaches in golf etiquette, the Country Club's rules and policies, careless play or operation of golf carts or interference or harassment of Country Club employees or other guests by any Participant or his/her/their guests. In the event participation is terminated, voluntarily or involuntarily, the Country Club will **not** refund any portion of the fee.
- F. Participants must present current membership card at the time of service and check in at the Willowcreek Pro Shop for services to receive your receipt for the starter. Participants must present current membership card or current bag tag to the range attendant for admittance to the member's only area of the Practice Facility.
- G. Fitness equipment is available adjacent to the men's and women's locker rooms. The fitness equipment is provided by the Country Club for use by our hotel guests and members of the Inner Club only. The area is not supervised and use of the equipment involves risk of injury, including death or serious disabling injuries, and that it is not possible to specifically list each and every individual risk. You expressly assume all of these risks, which could occur by reason of participation. You must be 18 years of age or older to use the equipment. You should consult with your physician before using the equipment. The use of the equipment is an implied agreement to waive any claim of liability for injury or damage against the Country Club.
- H. The Participant expressly agrees that he/she will not use the lockers for any unlawful purpose, and that he/she will not store perishable, explosive or highly flammable materials. The Participant can obtain insurance at his/her expense to cover the contents stored in the locker. The Country Club shall not be responsible for any damage or loss to the Participant's property caused by theft, fire, water, or otherwise. The Country Club expressly reserves the right to remove the Participant's lock and enter the locker in case of fire or other emergency or at the last day of the year to clean the locker and dispose of any contents left in the locker after the end of this agreement.
- I. Pace of Play Guidelines: We expect each group to take no more than 10 minutes per hole, your entire 9 Hole round should be a total of 90 minutes or less.
