

**ATKINSON RESORT & COUNTRY CLUB**  
**2018 CORPORATE RESORT MEMBERSHIP**

The Atkinson Resort & Country Club, 85 Country Club Drive, Atkinson, NH, 03811 ("Country Club"), 2018 Corporate Resort Membership package is referred to below as "Corporate Resort Membership".

The Applicant hereby applies to become a participant of "Corporate Resort Membership" during the year beginning January 1, 2018 and ending December 31, 2018.

Corporation defined as eligible companies filing as LLP, LLC, S-Corp, C-Corp or equivalent as defined under federal tax code. Proof of incorporation may be required. Sole proprietorships do not qualify.

1. Upon receipt by the Country Club of (a) this completed Application and (b) the annual fee for the amount of the package being chosen:
  - a. \$6,000 Primary cardholder
  - b. \$4,000 Second cardholder
  - c. \$3,000 Third cardholder
  - d. \$1,000 Fourth cardholder
  
2. Upon execution by Atkinson Resort & Country Club's Head Golf Professional, General Manager or Corporate Officer of this Agreement, Participant shall be admitted to and become a Participant ("Participant") of The Corporate Resort Membership.

Upon being accepted for participation in The Corporate Resort Membership, the primary cardholder and each additional participant on the account shall be entitled during the year to the following privileges:

1. Unlimited greens fees on the 18 Hole Par 72 course
  - Up to 3 additional guests per day at the Adult Inner Club rate. (does not include Senior or Junior discounted rates). Member must play with guest(s).
2. Unlimited greens fees on the 9 Hole Par 3 course
  - Up to 3 additional guests per day at the Adult Inner Club rate. Member must play with guest(s).
3. Discounted rates on golf carts
  - Adult Inner Club rates apply for up to 3 additional guests per day
4. Priority in reserving a tee time for up to **ten (10) days** in advance
  - Five (5) day advantage over non-participants
5. Unlimited Practice Facility privileges
  - Guests have practice facility privileges on the day of play.
  - During Hours of Operation
  - First Come, first serve basis
  - From April 1 - November 1
  - Excludes use of the Willowcreek Golf Academy
6. Discount on select merchandise
7. Complimentary Atkinson Resort & Country Club gift
8. 2018 USGA handicap service
9. Inner Club tournament participation
  - See Tournament Schedule (separate entry fees apply)
10. Golf club storage
  - From April 1 - November 1. Atkinson Resort does not assume any responsibility for lost or stolen items.
11. Men's and Women's locker room amenities
  - Guests have locker room privileges on the day of play. Atkinson Resort does not assume any responsibility for lost or stolen items.

- During posted hours
  - Locker use on first come first serve basis
  - Showers and towel service
  - Fitness equipment on first come first serve basis
12. Ten percent (10%) discount applicable to the corporate member only on all food and non-alcoholic beverage purchases for:
- Stagecoach Grille
  - Merrill's Tavern
  - Cartside Café
- \*Cannot be combined with any other offer, discount, coupon or promotional pricing. Additional restrictions apply.*
13. Fieldstone Suite corporate room rate of \$99 per night. (based on availability)
- Guests of corporate member also receive \$99 per night. (based on availability)
14. Personal Hospitality Sales Manager to manage and coordinate your Resort needs.

By applying for participation in The Corporate Resort Membership, Participant acknowledges, accepts and agrees to the following terms and conditions of his/her/their continued participation in The Corporate Resort Membership.

- A. This participation is not transferable to or useable by any other person or persons other than the Participant and the three additional eligible participants identified with the contract.
- B. Each Participant and their guests accept responsibility for compliance with the stated rules and policies of the Country Club.
- C. The Participant must notify the Country Club by telephone prior to the start of any tee time that the number in such Participant's party is not the number reserved for; failing which, the Country Club reserves the right to add waiting singles to the Participant's group. If a Participant shows up more than twice with fewer players in his/hers/their group than was previously booked and without such prior notice to the Country Club, the tee time booking privileges under the Corporate Resort Membership may be suspended or revoked.
- D. In the event Participant or any of his/her/their guests that form the group for which a reservation has been made is not checked in with the Willowcreek Pro Shop at least fifteen (15) minutes prior to the scheduled tee time the Country Club reserves the right to allow waiting groups to precede the Participant and cause the Participant and his/her/their group to forfeit their tee time.
- E. The Country Club reserves the right to terminate a Participants participation in Corporate Resort Membership for breaches in golf etiquette, the Country Club's rules and policies, careless play or operation of golf carts or interference or harassment of Country Club employees or other guests by any Participant or his/her/their guests. In the event participation is terminated, voluntarily or involuntarily, the Country Club will **not** refund any portion of the fee.
- F. Participants must present current membership card at the time of service and check in at the Willowcreek Pro Shop for services to receive your receipt for the starter. Participants must present current membership card or current bag tag to the range attendant for admittance to the member's only area of the Practice Facility
- G. Fitness equipment is available adjacent to the men's and women's locker rooms. The fitness equipment is provided by the Country Club for use by our hotel guests and members of the Inner Club only. The area is not supervised and use of the equipment involves risk of injury, including death or serious disabling injuries, and that it is not possible to specifically list each and every individual risk. You expressly assume all of these risks, which could occur by reason of participation. You must be 18 years of age or older to use the equipment. You should consult with your physician before using the equipment. The use of the equipment is an implied agreement to waive any claim of liability for injury or damage against the Country Club.
- H. The Participant expressly agrees that he/she will not use the lockers for any unlawful purpose, and that he/she will not store perishable, explosive or highly flammable materials. The Participant can obtain insurance at his/her expense to cover the contents stored in the locker. The Country Club shall not be responsible for any damage or loss to the Participant's property caused by theft, fire, water, or otherwise. The Country Club expressly reserves the right to remove the Participant's lock and enter the locker in case of fire or other emergency or at the last day of the year to clean the locker and dispose of any contents left in the locker after the end of this agreement.

- I. Pace of Play Guidelines: Pace of Play Guidelines: 18 Hole rounds of golf should be played in 4 hours and 30 minutes or less. If participant's group falls behind the group playing in front, you will be asked by a Ranger to pick up the pace of play and "get back in position" on the golf course. If a ranger must speak to your group a second time, you will be asked to move into position on the golf course. Please remember that the group in front of you determines your pace, not the group behind.
- J. To provide the utmost in customer service, each participant will be assigned a personal Hospitality Sales Manager. Each time the participant would like to book a banquet event, reserve a hotel room or make a restaurant reservation a single call to their Hospitality Sales Manager is all that is needed. The Sales Manager will take care of making all the necessary arrangements thus allowing more time for participants to relax and enjoy the resort.
- K. The REFERRAL BONUS for Membership will apply only if an individual is NEW or RETURNING from a year prior to 2014. Individuals who have been Inner Club Members more recently than December 31<sup>st</sup>, 2013 are not eligible for the REFERRAL BONUS. The REFERRAL BONUS will apply only to one current membership number and will be in the form of a matching Resort Rewards contribution equal to the Resort Reward Tier for the value of the membership purchased. A NEW or RETURNING individual is not eligible to receive additional bonus amounts on the purchase of their own Membership. For NEW or RETURNING Members to receive a REFERRAL BONUS they must refer another NEW or RETURNING Member with a separate Rewards Account.
