2018 JUNIOR PLATINUM SEASON INNER CLUB PACKAGE CONTRACT

The Atkinson Resort & Country Club, 85 Country Club Drive, Atkinson, NH, 03811 ("Country Club"), 2017 Junior Platinum Season Inner Club package is referred to below as "Junior Platinum Season Package".

The Applicant hereby applies to become a participant of a "Junior Platinum Season Package" beginning _____ and ending December 31, 2018.

1. Upon receipt by the Country Club of (a) the completed Contract, (b) the completed applicant's information form and (c) the annual fee for the package being chosen:
 - a. \$1,100 per individual
 - i. All Members must be between the ages of **10 and 17** before **April 1, 2018**.
 - ii. Previous playing experience is required to be considered for Junior Platinum Season Package. The assessment by the Head Golf Professional of the skill level of the applicant in determining eligibility for the Junior Platinum Package is final.
2. Upon execution by the Country Club's Head Golf Professional, Director of Golf, General Manager, or Corporate Officer of this agreement, the applicant shall be admitted to and become a Participant ("Participant") of a Junior Platinum Season Package.

Upon being accepted for participation in the Junior Platinum Season Package, Participants shall be entitled during the current year to the following privileges:

1. Unlimited greens fees on the 18 Hole Par 72 course
 - Monday through Thursday anytime
 - Fridays, Saturdays, Sundays and holidays after 12:00 pm
2. Unlimited greens fees on the 9 Hole Par 3 course
 - No time restrictions
3. Discounted rates on golf carts
 - See rate sheet
 - Valid driver's license required
4. Priority in reserving a tee time for up to **ten (10) days** in advance
 - Five (5) day advantage over non-participants
5. Unlimited Practice Facility privileges
 - During hours of operation
 - First come, first serve basis
 - From April 1 - November 1
 - Excludes use of Willowcreek Golf Academy
6. One (1) hour free golf lesson with Brian Diamond
7. Discount on select merchandise
8. Complimentary Atkinson Resort & Country Club gift
9. 2018 USGA handicap service.
10. Inner Club tournament participation (upon approval)
 - See Tournament Schedule (separate entry fees apply)
11. Golf club storage
 - From April 1 - November 1. Atkinson Resort does not assume any responsibility for lost or stolen items.
12. Discounted virtual golf rates in Merrill's Tavern Game Room
13. Fieldstone Suites room rate of \$99 per night (based on availability)

By applying for participation in Junior Platinum Season Package, Responsible Party on behalf of, and Participant acknowledges, accepts and agrees to the following terms and conditions of his/her continued participation in Junior Platinum Season Package.

- A. This participation is not transferable to or useable by any other person or persons other than the Participant themselves.
- B. Each Participant and their guests accept responsibility for compliance with the stated rules and policies of the Country Club.
- C. The Participant must notify the Country Club by telephone prior to the start of any tee time that the number in such Participant's party is not the number reserved for; failing which, the Country Club reserves the right to add waiting singles to the Participant's group. If a Participant shows up more than twice with fewer players in his/her/their group than was previously booked, and without such prior notice to the Country Club, the tee time booking privileges under Junior Platinum Package may be suspended or revoked.
- D. In the event Participant or any of his/her/their guests that form the group for which a reservation has been made is not checked in with The Willowcreek Pro Shop at least fifteen (15) minutes prior to the scheduled tee time the Country Club reserves the right to allow waiting groups to precede the Participant and cause the Participant and his/her/their group to forfeit their tee time.
- E. The Country Club reserves the right to terminate a Participants participation in the Junior Platinum Season Package for breaches in golf etiquette, the Country Club's rules and policies, careless play or operation of golf carts or interference or harassment of the Country Club employees or other guests by any Participant or his/her/their guests. In the event participation is terminated, voluntarily or involuntarily, the Country Club will **not** refund any portion of the fee.
- F. Participants must present current membership card at the time of service and check in at the Willowcreek Pro Shop for services & to receive your receipt for the starter. Participants must present current membership card or current bag tag to the range attendant for admittance to the member's only area of the Practice Facility
- G. Participant and Responsible Party accept responsibility for compliance with the attached rules and policies of The Country Club by the Participant and any guests, and agree that Participant shall not consume any alcoholic beverages or tobacco products anywhere on the Country Club premises.
- H. Golf Carts will only be rented to Junior Platinum Package members who hold a valid drivers license and is familiar with the operations of a golf cart.
- I. Pace of Play Guidelines: Pace of Play Guidelines: 18 Hole rounds of golf should be played in 4 hours and 30 minutes. If participant's group falls behind the group playing in front, you will be asked by a Ranger to pick up the pace of play and "get back in position" on the golf course. If a ranger has to speak to your group a second time, you will be asked to move into position on the golf course. Please remember that the group in front of you determines your pace, not the group behind.
- J. The Country Club assumes no responsibility in the supervision of a Junior Platinum Season Package member while he/she is on the Country Club premises.
- K. The REFERRAL BONUS for Membership will apply only if an individual is NEW or RETURNING from a year prior to 2014. Individuals who have been Inner Club Members more recently than December 31st, 2013 are not eligible for the REFERRAL BONUS. The REFERRAL BONUS will apply only to one current membership number and will be in the form of a matching Resort Rewards contribution equal to the Resort Reward Tier for the value of the membership purchased. A NEW or RETURNING individual is not eligible to receive additional bonus amounts on the purchase of their own Membership. For NEW or RETURNING Members to receive a REFERRAL BONUS they must refer another NEW or RETURNING Member with a separate Rewards Account.
