- A. This participation is not transferable to or useable by any other person or persons other than the Participant themselves.
- B. Each Participant and their guests accept responsibility for compliance with the stated rules and policies of the Country Club.
- C. The Participant must notify the Country Club by telephone prior to the start of any tee time that the number in such Participant's party is not the number reserved for; failing which, the Country Club reserves the right to add waiting singles to the Participant's group. If a Participant shows up more than twice with fewer players in his/hers/their group than was previously booked and without such prior notice to the Country Club, the tee time booking privileges under the Young Professional Platinum Season Package may be suspended or revoked.
- D. In the event Participant or any of his/her/their guests that form the group for which a reservation has been made is not checked in with the Willowcreek Pro Shop at least fifteen (15) minutes prior to the scheduled tee time the Country Club reserves the right to allow waiting groups to precede the Participant and cause the Participant and his/her/their group to forfeit their tee time.
- E. The Country Club reserves the right to terminate a Participants participation in Young Professional Platinum Season Package for breaches in golf etiquette, the Country Club's rules and policies, careless play or operation of golf carts or interference or harassment of Country Club employees or other guests by any Participant or his/her/their guests. In the event participation is terminated, voluntarily or involuntarily, the Country Club will not refund any portion of the fee.
- F. Participants must present current membership card at the time of service and check in at the Willowcreek Pro Shop for services to receive your receipt for the starter. Participants must present current membership card or current bag tag to the range attendant for admittance to the Member's only area of the Practice Facility
- G. Fitness equipment is available adjacent to the men's and women's locker rooms. The fitness equipment is provided by the Country Club for use by our hotel guests and Members of the Inner Club only. The area is not supervised and use of the equipment involves risk of injury, including death or serious disabling injuries, and that it is not possible to specifically list each individual risk. You expressly assume these risks, which could occur due to participation. You must be 18 years of age or older to use the equipment. You should consult with your physician before using the equipment. The use of the equipment is an implied agreement to waive any claim of liability for injury or damage against the Country Club.
- H. The Participant expressly agrees that he/she will not use the lockers for any unlawful purpose, and that he/she will not store perishable, explosive or highly flammable materials. The Participant can obtain insurance at his/her expense to cover the contents stored in the locker. The Country Club shall not be responsible for any damage or loss to the Participant's property caused by theft, fire, water, or otherwise. The Country Club expressly reserves the right to remove the Participant's lock and enter the locker in case of fire or other emergency or at the last day of the year to clean the locker and dispose of any contents left in the locker after the end of this agreement.
- I. Pace of Play Guidelines: Pace of Play Guidelines: 18 Hole rounds of golf should be played in 4 hours and 30 minutes. If participant's group falls behind the group playing in front, you will be asked by a Ranger to pick up the pace of play and "get back in position" on the golf course. If a ranger must speak to your group a second time, you will be asked to move into position on the golf course. Please remember that the group in front of you determines your pace, not the group behind.
- J. The REFERRAL BONUS for Membership will apply only if an individual is NEW or RETURNING from a year prior to 2014. Individuals who have been Inner Club Members more recently than December 31<sup>st</sup>, 2013 are not eligible for the REFERRAL BONUS. The REFERRAL BONUS will apply only to one current membership number and will be in the form of a matching Resort Rewards contribution equal to the Resort Reward Tier for the value of the membership purchased.
